3. Purpose of the processing

The personal data are processed for creation of user accounts for ASTRA which is the ECB's platform for external collaboration and document exchange (based on OpenText Core). In order to create accounts for the external users to access the platform and authenticate securely, personal information is a mandatory requirement. The personal data is collected by ECB staff for the purpose of creating user accounts in OneWelcome (system that provides access to multiple ECB externally facing applications). OneWelcome requires multifactor authentication by default, and therefore the full name, phone number and email address are required. This data, excluding the phone number, is automatically synchronised between OneWelcome and ASTRA, in order to allow the basic functionalities of the system (provide granular access to different areas of ASTRA and ensure traceability of the access to each document in line with DG-IS Security Policies).

In ASTRA, the personal data (name and email address) will be kept in the audit log until the documents are deleted manually or, at the latest, in accordance with the retention period applicable to the document under the ECB Filing and Retention Plan.
