

SCoRE Implementation Monitoring

Billing Processes – H1 2021

Polish NSG

The Single Collateral Management Rulebook for Europe (SCoRE) contains 4 Standards related to billing processes (published as the AMI-SeCo Standards for Billing Processes). Implementation progress is monitored twice per year. This summary report presents the results of the H1 2021 monitoring exercise conducted by the Polish NSG with the involvement of the following stakeholders:

33 entities are monitored in the Polish market

- 2 CSD KDPW, SKARBNET4
- 31 Custodians

The SCoRE Overview provides a high-level summary of the H1 2021 monitoring exercise.

This NSG summary report is structured as follows: The Executive Summary provides an overview of the responses received per Entity Type i.e. CSD, TPA, Custodian etc. Section 1 presents the compliance status of each entity type. Section 2 provides an overview of the progress against the individual milestones. Section 3 then provides a more detailed overview of the implementation status per Standard for each entity type.

Executive Summary

Implementation of the Billing Processes Standards in the Polish market is mostly on track. Concerning the major Poland financial market infrastructure institution, namely the KDPW SA, the implementation of the Billing Processes Standards is either completed or is on track. The Standards are deemed to be met on time. The process of implementation of the Standards by SKARBNET4 is also advanced although due to specific range of activities performed by the system, it is restricted to one standard as the remaining Standards were deemed not applicable. Regarding custodians, only three out of 31 reporting entities responded to the survey. The majority of the custodians did not participate in the monitoring process. AMI-SeCo NSG_PL will endeavour to engage the custodians in the process within its next rounds.

CSD - KDPW

The CSD KDPW is fully on track.

KDPW is already compliant to a large extent with the Billing Processes Standards. It is fully compliant with Standard 2 on billing cycles and Standard 3 on cut-off date. The implementation of the two remaining standards: Standard 1 on ISO 20022 messaging and Standard 4 on dates for payments fees, is subject to analysis scheduled to be finished by the beginning of 2022.

Although the initial communication has not started yet it is expected that most of the succeeding milestones will be met on time and the implementation date of November 2023 will be met.

CSD - SKARBNET4

The CSD SKARBNET4 are experiencing some delays but still foresee to meet the final implementation date in November 2023.

SKARBNET4 is a system operated by Narodowy Bank Polski. It serves exclusively T-bills (issued by Ministry of Finance periodically) and NBP-bills (issued by NBP in open market operations which are the main instrument of monetary policy) basically primary market which entails relatively small group of highly expertised institutions (mainly banks). Moreover, SKARBNET4 has no operational connections with other deposits. Therefore, the billing processes in the system are simplified and additionally the billing cycle in SKARBNET4 is synchronized with the fees charged by NBP for keeping cash accounts in the RTGS PLN system - SORBNET2.

Full implementation of the Standards would increase unproportionally and counterproductively the processes currently in place. Against this background the operator of the system decided to implement Standard 1 on ISO messaging as far as it concerns provide camt.077 messages, recognising the remaining Standards as not applicable. With regard to the Standard 1 the operator of the system does not anticipate receiving any billing information using the Billing Report message (camt.077) from SKARBNET4 participants.

The remaining standards are not applicable as the only fee charged for providing deposit account in SKARBNET4 (in addition to a one-time fee of PLN 25,000.00 for opening the account) is a flat fee of PLN 3,000.00. The fee is collected once per quarter and is equal for all participants, therefore participants do not have to check the correctness of its calculation. Furthermore, the fee is collected by NBP by debiting a participant's bank account on the basis of its prior authorization.

Therefore, NBP does not issue invoices and a participant does not have to issue the order himself.

The delay in starting the implementation of the abovementioned Standard was due to previously commenced process of implementation of the regulation 2018/1229 (settlement discipline), which turned out to be very demanding. Initial high-level communication with external stakeholders on the changes introduced by SCoRE has not yet commenced. It is however scheduled to start by the end of March 2022. Meeting the milestones no. 3-6 will be slightly delayed. The succeeding milestones are deemed to be met on time and the implementation date of November 2023 will be met.

Custodians

Low participation among custodians.

Only three out of 31 reporting entities responded to the survey. The majority of custodians did not participate in the monitoring process. After the analysis of the Standards one of the three reporting custodians has withdrawn from participating in the study as it deemed SCoRE not relevant in terms of the scope of its activity.

The reporting entities declared to be compliant with Standard 2 on billing cycles. The standard is reported as implemented. The implementation of the remaining Standards is declared to be postponed until either 2025 or the Wave 2, when account servicers will be obliged to offer ISO20022 messaging to clients that have the capability to use the ISO20022 protocol.

1 SCoREBOARD

This section presents the overall compliance status in the market. CSDs and TPAs are monitored on an individual basis and are assigned a colour-code status in accordance with the methodology outlined in Box 1¹. Custodians are monitored on an aggregated basis and assigned a percentage compliance status.

Box 1SCoREBOARD – Implementation Phase

For custodians, progress is monitored and reported as a percentage; for example the % of custodians in a given market who have started internal adaptation of IT systems.




Implementation Status per AMI-SeCo Standard


Implementation Status per AMI-SeCo Standard
