Reason for change and expected benefits/business motivation:

During the Start of Day (SOD) T2S cannot provide settlement information regarding securities account positions and cash balances. This includes any account positions or balances required by query management. At night-time settlement (NTS) such A2A queries are queued during NTS sequences and provided once the sequence has been completed. During real-time settlement (RTS) they are provided without queuing. In U2A, these queries are only available in-between night-time settlement sequences.

The current implementation provides an ambiguous response when querying for securities account positions and cash balances during the SOD. In A2A, for example, the current response to a SecuritiesAccountPositionQuery (semt.025) during the SOD is a SecuritiesStatusOrStatementQueryStatusAdvice (sese.022) with the code X000 'No data found or no data found within the user's allowed data scope'. In U2A, the current response shows the empty list screen containing "No data found".

An additional code should be added to T2S to more clearly describe that during this SOD period the settlement data is unavailable.

Description of requested change:

A distinct error code is required to report the unavailability of settlement data (including securities position and cash balance information) during the SOD. This new code should clarify that queries received during SOD and requiring information from settlement are not queued and will result in operational errors due to the unavailability of settlement related data. In A2A, this code will be reported using the respective operational error message (e. g. SecuritiesStatusOrStatementQueryStatusAdvice (sese.022)) as is the case for the current code returned in these circumstances.

In U2A, the respective screens will not be displayed during the SOD. This avoids during SOD the ambiguous response mentioned above and ensures consistency to the behaviour during NTS sequences.

3.2.4.3 Description of the functions of the module

Inbound Processing Module – Application-to-Application

[...]

5 - Check for A2A Inbound Queuing

This function receives the following data flows:

- I Inbound business data;
- Start Queuing System Status events;
- I End Queuing System Status events;
- I Inbound processing rejection Query Queuing.

It checks if the A2A request can be forwarded or if it has to be queued. Queuing is relevant for:

- All requests during maintenance window {T2S.03.230};
- I For Liquidity Transfers
 - Between Business date change and Change of business date completed and
 - During cycle 2 / preparation of sequence y
- I Securities position related Queries during sequences with impact on positions.
- Balance Queries during night time sequences {T2S.14.080}.

Note: Queries sent in A2A mode during SOD requiring information from settlement are not queued and will result in a message specifying the unavailability of settlement related data.

Inbound Processing Module – User-to-Application [...]

3 – Check for U2A Availability

This function receives the following data flows:

- I Inbound business data;
- Start Queuing System status events;
- End Queuing System status events.

The events concerning the System Status inform the function about the current system status therefore they enable the function to check on the availability. The function uses this information for processing the *Inbound business data* flow.

After receiving the *Inbound business data* flow the function checks, if the U2A request has to be rejected due to restricted availability for the dedicated functionality. This is relevant for:

- Liquidity Transfers
 - Between Business date change and Change of business date completed and
 - During cycle 2 / preparation of sequence y
- I Securities position related Queries during sequences with impact on positions
- Balance Queries **{T2S.14.080}** during night-time sequence.
- Queries during SOD requiring information from settlement

If both conditions are fulfilled, the function rejects the request due to running sequence. It therefore creates an *Inbound* processing rejection – U2A Availability flow.

The function forwards all other Inbound business data flows to the Information Router function.

- <u>T2S Dedicated Cash Account Balance Detailed Restrictions query.</u>
