#### Reason for change and expected benefits/business motivation:

Currently the DMT baseline specification does not cover the option to migrate pending settlement instructions. This would require that instructions have to be migrated using an upload of A2A messages or files. The upload of those instructions would only be possible during the related phase of the migration weekend, as otherwise validations might fail due to incomplete static data. This limitation increases the risks of delays or problems during the migration weekend, as any problem with the connectivity or the upload of those messages/files would result in such a delay.

By allowing the upload of pending instructions via the DMT those files can be uploaded at an earlier point in the migration process, thus reducing the time dependencies on this activity, as the T2S Operator would trigger the processing of those files only during the relevant phase of the migration weekend. Moreover, the DMT would be a good contingency mean in case problems are encountered with the connectivity or the upload of messages/files via A2A during the migration weekend.

Implementing this CR would therefore increase the control on the migration process and mitigate the risks of delays caused by these activities.

#### Description of requested change:

The purpose of the change is to include the support for pending settlement instructions in the Data Migration Tool (DMT) to allow CSDs to migrate such instructions not only via A2A / U2A, but using the DMT.

## Proposed wording for the Change request:

The last paragraph of chapter 3.2 (Data coverage of the DMT) should be modified as follows:

As regards the dynamic data the DMT covers:

- the migration of pending settlement instructions, and
- the migration of the initial positions on the securities accounts via FOP instructions during the migration weekends;

The migration of <del>pending settlement instructions,</del> settlement restrictions and maintenance instructions is essentially the same as the submission of these instructions as part of the normal T2S operations of CSDs. These instructions will therefore not be covered by the DMT.

CR 0385 is proposing a change to the same paragraph. If both CRs are approved, the paragraph should be modified as

follows:

As regards the dynamic data the DMT covers:

- the migration of pending settlement instructions, and
- the migration of the initial positions on the securities accounts via FOP instructions <u>and intra-position</u> movements (for blocked, reserved and earmarked positions) via the securities restrictions

during the migration weekends.

The migration of pending settlement instructions, settlement restrictions and maintenance instructions is essentially the same as the submission of these instructions as part of the normal T2S operations of CSDs. These instructions will therefore not be covered by the DMT.

High level description of Impact:

### **Outcome/Decisions:**

- CSG meeting of 13 December 2012: The CSG decided to request the detailed assessment by the 4CB when the expected clarification of the Migration Sub-group is available.

- Migration Sub-group meeting on 22-23 January 2013: It provided the detailed requirement related to the Migration of pending instructions (fields). These requirements are attached to this Change Request.

- CRG meeting on 25 March 2013: Based on the detailed assessments of CR 386 and taking into account that it could be implemented before the start of the User Testing phase; the CRG proposed that the CR 386 should be submitted to the Steering level for approval.

- CSG resolution on 5 April 2013: Following a written procedure, the CSG adopted the resolution to approve the Change Request.

- Advisory Group's advice on 5 April 2013: Following a written procedure, the AG was in favour of the Change Request.

<sup>-</sup> CRG Telco on 10 December 2012: The CRG recommended a detailed assessment by 4CB when a clarification is provided by Migration Sub-group concerning the scope of the pending instructions that are supported (e.g. which message fields are to be supported by the DMT). This additional information is seen as a pre-condition for the detailed assessment by 4CB.
