Reason for change and expected benefits/business motivation:

When reporting information on the activities on static data object (Party, Securities, Securities Account and T2S Dedicated Cash Accounts), for the restriction types the reports show only the amended field and this does not allow to uniquely identifying the restriction type impacted by the amendment.

The proposal is to use the returned Field Name in order to contain, in a single string, all the needed pieces of information in order to identify the item impacted and the changed attributes (Restriction Type Code, Valid From Timestamp, and Short mnemonic for the attribute).

This Change Request is based on PBI000000158671 (Static data statements not reporting Restriction Type codes).

Description of requested change:

The attribute Field Name (FldNm) shall contain a string pattern in order to identify the restriction type. Suggestion is to use this pattern:

- [restriction type code]/[valid from timestamp]/RTY. RTY is a short mnemonic code for "Restriction Type"
- [restriction type code]/[valid from timestamp]/VFR. VFR is a short mnemonic code for "Valid From"
- [restriction type code]/[valid from timestamp]/VTO. VTO is a short mnemonic code for "Valid To".

The impact is on Statement of Static Data for Party (PartyActivityAdvice = reda.041), Statement of Static Data for Securities (SecurityActivityAdvice = reda.009), Statement of Static Data for Securities Accounts (SecuritiesAccountActivityAdvice = reda.035), Statement of Static Data for T2S Dedicated Cash Accounts (CashAccountActivityAdvice = reda.038).

The UDFS shall explain the interpretation of the content of the FldNm attribute.
