Reason for change and expected benefits/business motivation:

This Change Request is based on PBI000000158460.

The information shown for the "Pending Cancellation" field in the Cancellation Securities Instruction – Details screen should be consistent with the applicable reason code of the Cancellation Instruction "CONF" (i.e. Cancellation pending, awaiting for cancellation from the counterparty) and with the value "CDAC" (i.e. Cancellation pending from Administering Party). Therefore the "pending cancellation" field must be set to "Yes" when one of these reason codes applies to the Cancellation Instruction.

Moreover, in case there is a Cancellation Instruction which is not executed due to the reason codes "CONF" or "CDAC", the applicable reason code needs to be reported in the SecuritiesTransactionCancellationRequestReportV01 semt.033 message

Description of requested change:

The reporting of the "pending cancellation" reason code for a Cancellation Instruction needs to be updated as follows:

- In U2A. The field "Pending Cancellation" of the Cancellation Securities Instruction Details screen must be set to "Yes" in case there is an applicable reason code "CONF" or "CDAC" for the Cancellation Instruction.
- In A2A. The message item "Pending Cancellation reason code"

(SctiesTxCxlReqRpt/Cxls/PrcgSts/PdgCxl/Rsn/Cd/Cd) must include the applicable reason code "CONF" or "CDAC" for the applicable Cancellation Instruction.

UHB v2.1 Chapter 2.2.2.18 Settlement Instruction - Details Screen:

Update the Cancellation Requested field description as follows:

"Shows if the settlement instruction has been requested for cancellation by its counterpart from the possible values:

- Empty (default value)
- -**I**-No

I Yes

This situation occurs when the counterparty's cancellation instruction is processed in T2S."

UHB v2.1 Chapter 2.2.2.5 Cancellation Securities Instruction – Details Screen:

Update the Pending Cancellation field description as follows:

"Shows if the counterparty has already sent its cancellation instruction <u>Cancellation Instruction is pending to be</u> <u>executed</u>, <u>awaiting for cancellation from the counterparty or CoSD cancellation from another administering party</u> from the possible values:

I <u>Empty (default value)</u> I Yes I No "

Update the T2S-Use of the "Pending Cancellation" processing status of the semt.033 message in the semt.033 message pdf documentation available in Mystandards.

The drafting should be as follows:

"T2S sends a pending status to the T2S Actor who instructed the Cancellation Instruction to inform that the cancellation request is pending until its counterparty sends the corresponding Cancellation Instruction <u>or the necessary</u> <u>Administering Party(-ies) sends the corresponding CoSD Cancellation Instruction.</u>"

High level description of Impact:

Outcome/Decisions:

* CRG written procedure from 4 to 8 March 2016: The CRG recommended the launch of the detailed assessment.

* OMG feedback on 15 March 2016: Following the OMG written procedure from 8 to 15 March 2016, OMG indicated that there was no operational impact of the Change Request.

* Advisory Group's advice on 24 March 2016: Following a written procedure from 18 to 24 March 2016, the AG was in favour of launching the detailed assessment on the Change Request.
