## Reason for change and expected benefits/business motivation:

Following the migration of ESES CSDs to the T2S platform, we can observe that at the end of the Night Time Settlement there are an important number of transactions that are still pending either due to lack of resources or because these instructions were put on hold by the parties of the transactions. These instructions are then recycled in the Real Time Settlement process. However, even if in the meantime resources are available or the transactions are released, many of these instructions remain pending until the first Partial Settlement window (at 10 am).

The introduction of a new partial settlement window during the RTS at 8am will allow settling earlier than today the pending instructions remaining from the nigh-time settlement. In general it should improve the overall settlement efficiency by providing an additional opportunity to optimise the settlement process.

## Description of requested change:

Introduction of a new partial settlement window at 8 am during the real-time settlement (RTS).

# Partial settlement during daytime settlement

T2S shall activate partial settlement procedure

- at 08:00 CET, with deactivation at 08:15 CET
- at 10:00 CET, with deactivation at 10:15 CET
- at 12:00 CET, with deactivation at 12:15 CET
- at 14:00 CET, with deactivation at 14:15 CET
- at 15:45 (15 minutes before the DVP cut-off time), with deactivation at the closure of the same day T2S DVP settlement.

- The real-time settlement preparation;
- The real-time settlement with the <u>four five</u> partial settlement windows to optimise maximum value and volumes of settlement transactions, which are unsettled because of lack of securities:
  - The first partial settlement window between 08:00 a.m. and 08:15 a.m.;
  - The second first partial settlement window between 10:00 a.m. and 10:15 a.m.;
  - The third second partial settlement window between 12:00 p.m. and 12:15 p.m.;
  - The fourth third partial settlement window between 2:00 p.m. and 2:15 p.m.;
  - The <u>fifth fourth</u> partial settlement window is 15 minutes before the beginning of the DVP cut-off time, then between 3:45 p.m. and 4:00 p.m.

## High level description of Impact:

#### Outcome/Decisions:

\* CRG meeting on 12-13 December 2016: The CRG recommended the approval of the Change Request (with the timing of 7 am) and its inclusion in the T2S Release 1.2.2.

\* OMG meeting on 14-15 December 2016: The OMG raised objections about the inclusion in the T2S Release 1.2.2 and was of the view that a decision cannot be taken before the migration of wave 4.

\* RMSG teleconference on 16 December 2016: The RMSG raised objections about the inclusion in the T2S Release 1.2.2 and was of the view that a decision cannot be taken before the migration of wave 4.

\* OMG teleconference on 11 May 2017: The OMG agreed that a new partial settlement window at 8 am plus the current partial settlement window at 10 am would be most effective combination of partial settlement windows in the mornings.

\* CRG teleconference on 18 May 2017: The CRG recommended the approval of the Change Request with the new timing (8 am instead of 7 am).

\* Advisory Group on Market Infrastructures for Securities and Collateral (AMI-SeCo) on 30 May 2017: Following a written procedure from 24 to 30 May 2017, the AMI-SeCo was in favour of approving the Change Request.

\* CSD Steering Group on 31 May 2017: Following a written procedure from 24 to 31 May 2017, the CSG adopted the resolution to approve the Change Request.
