Outcome of the T2S Project Managers Group (PMG) Meeting

9 March 2022 (09:30-12:30 & 14:00 - 17:00)

1. APPROVAL OF THE AGENDA AND INTRODUCTORY REMARKS

Outcome

The PMG chairperson welcomed the participants and introduced the meeting, held remotely due to COVID-19 precautionary measures. No additional items were proposed for inclusion on the agenda of the meeting. The PMG members approved the agenda.

The PMG was updated on the authorisations and approvals from CSG/NECSG/MIB since the last PMG meeting on 19 January 2022:

- Since the last PMG meeting of 10 November, the following CRs were authorised by the T2S Steering level:
 - T2S-0772-SYS (Export of T2S cash transactional data from the Data Warehouse to a Eurosystem's monetary policy application)
 - T2S-0777-SYS (Unprune elements of the semt.002 message to allow their use by ECMS)
 - T2S-0779-SYS (Optimise processing of CORP transactions during Real Time Settlement: grouping in collections and modified sorting method)
 - T2S-0781-SYS (Allowing Security Intraday Restriction maintenance on or after Maturity Date)
- Since the last PMG meeting of 19 January, the following CRs were approved for implementation by the T2S Steering level:
 - T2S-0761-SYS (Enhance optimisation during RTS to maximise transaction throughput on the same resource)
 - T2S-0778 (Technical upgrade of the PROD environment to support increase in the number of Securities Accounts) approved to deploy CR-778 outside of a scope of a T2S Release.

The PMG was informed that following the written procedure across the technical groups on the OGPF proposals for updates, comments are being reviewed and the drafting suggestions will be circulated for a written procedure soon and thus item 9 was withdrawn from the agenda.

Outcome

The PMG took note of the CRG updates following their meeting on 28 February 2022.

The PMG also took note of the Unicity constraint on the Party BIC of cash parties, which may result in unexpected outcomes in the test environment when T2S and T2 are connected. It was agreed that the ECB will liaise with the relevant NCBs via the respective TSWG representative for the BICs to be corrected. The PMG took note that an automatic filter preventing duplicate BICs from being propagated to CLM (as described in the T2 clarification note SDD-CN-PBR-061) would be in place in the T2 test environments from 1 April 2022.

The PMG took note of the results of the Detailed Assessment for Change Request T2S-0551-SYS, T2S-0740-SYS, T2S-0763-SYS and T2S-0764-SYS. The PMG agreed to recommend CR-551, CR-740, CR-763 and CR-764 for implementation in R7.0 to the T2S Steering Level, subject to UTSG and OMG conclusion of testing coverage and operation assessment, respectively. The PMG agreed to revisit the CRs and their release allocation after the 15th March decision of the CSG on the option for the R6.0 delay.

F. 4CB CR Capacity consumption update

The PMG took note of the 4CB CR capacity consumption update, including the 7 CRs added to the update: CR-551, CR-740, CR-761, CR-762, CR-763 and CR-764. The PMG took note of the increases in the consumption for 2002, 2023 and 2024. The PMG took note that next CR implementation capacity update will be provided by end of March 2022 which will be significantly revised due to the inclusion of the CRS relating to the T2S Recovery solution.

5. CRs IMPACTING COMMON COMPONENTS

5.1 CRs raised by the T2S community Background documentation:

Outcome

The PMG took note of the impacts of CR-762 (New option for opening T2S during the week-end) in T2, and that a CR for T2 is therefore needed. The PMG took note that this T2 CR has now been raised as T2 CR-105, and it covers the need to plan activities on T2 side for the assumed 1x / year where the CR-762 would be used. The PMG was informed that the detailed assessment of T2 CR-105 is due end May 2022.

Outcome

A. CSLD CR-0087 and T2S CR-782 - oral update

The PMG took note of CSLD CR-0087 (in the context of the onboarding of DKK as a settlement currency in T2). The PMG was informed that while the CSLD CR is yet to be detailed assessed, it can already be expected that a number of changes will also be needed in T2S, which is being compiled in a new T2S CR. The PMG was informed that in the next steps, the CRG will be invited via written procedure to authorise CR-782.

B. ECMS CR-0034 and T2S CR-777 - oral update

The PMG took note of the updates of ECMS CR-0034 and the ongoing DA of CR-777, with expected delivery by 8 April 2022.

Outcome

A. Update on the User Testing activities

The PMG took note of R6.0 testing reporting activities in EAC, including R6.0 weekly testing report, ESMIG Connectivity for DiCoAs report, ESMIG Connectivity for CSDs and CBs reports (on 10 and 24 March 2022) and the testing reports for CR-705 and CR-722. The PMG agreed to activate the U2A NRO in CRDM (T2S CR-705) in EAC as of Thursday 10 March 2022, due to the urgent need to test the CRDM NRO by 15 March 2022. The U2A NRO will be active in CRDM until at least 15 March 2022, cob. Further follow-ups to be discussed by PMG in the agreed ad-hoc PMG meeting on 15 March 2022.

The PMG also requested the addition of further EAC deployment dates, e.g. on a weekly basis in order to facilitate a speedier deployment of open RDs. In addition, 4CB mentioned that the processing power of the test environments has been increased by 30% in order to ensure an even higher degree of stability.

The PMG took note the testing progress report of the Euroclear Finland on-boarding in T2S. The PMG took note that the status of Internal Acceptance Tests of Euroclear Finland have changed from green (as of January 2022) to yellow. PMG members were informed that these tests are ongoing for 5 of its 6 releases but progress has been significantly impacted by the limited deployment of R6.0 to EAC.

C. Euroclear Bank onboarding to T2S

PMG members were informed that the CSG mandated, in their meeting on 2/3 March 2022, the T2S technical groups to initiate the work on the onboarding of Euroclear Bank. The PMG took note of the onboarding activities and timeline for Euroclear Bank's phased approach. The PMG agreed to discuss on 29 March 2022 the detailed testing and migration planning of Euroclear Bank which should be a rolling plan, i.e. a greater detail on the first two phases and the major milestones for phases 3 and 4, consistent with Euroclear Bank's request to the MIB.

Outcome

The PMG took note of the findings and recommendations from the 2020 T2S External Examination, on Governance Topics and Functional and Application Controls, which the PMG required further clarifications during its meeting on 19 January 2022. The PMG agreed to update the description of AP 33 with a view of reviewing this again in Q3 2022 and whether the risk/issues could be recorded in the STP. The PMG agreed to close AP 28. The AP 29 on the rollback procedures would be revised reflecting the expectancy of an OMG discussion/conclusion.
