#### Reason for change and expected benefits/business motivation:

The proposed change aims at updating the TIPS message specifications for non-Euro currencies in order to comply with the document published by the Nordic Payment Council (NPC):

NPC012-01 NCT Inst Inter-PSP Implementation Guidelines (IG) 2023 v1.0

#### **Description of requested change:**

TIPS message specifications currently in place for non-Euro currencies have been designed in compliance with the requirements stemming from the change requests *TIPS.0030.URD* and *TIPS.0031.URD*.

Due to the release of the new version of the NPC Instant Credit Transfer specifications for 2023, a detailed gap analysis has been performed by the Sveriges Riksbank to highlight the compulsory changes to be applied to the TIPS non-Euro message specifications, in order to comply with the updated NCT Implementation Guidelines.

The following changes have been identified:

- o extension of the structured sub-elements of "postal address", with a dedicated NPC usage rule;
- pacs.004/camt.029/camt.056: new optional sub-element "Purpose" under "Original Transaction Reference";
- the element "*Currency*" under Debtor account and Creditor Account needs to be added as an optional element, where applicable, in all relevant messages.

TIPS message specifications for non-Euro currencies should be updated in order to include the abovementioned changes.

The exact timing and manner in which the updated version of non-Euro message specifications will enter into force in November 2023 is still under discussion and it requires further clarifications. Therefore, this change request does not contain any requirement on the rollout mode, that will eventually be part of a separate change request.

Summary of functional, development, infrastructure, operational and security impacts

Summary of functional impact:

In order to comply with the updated NCT Implementation Guidelines, an adaptation of the Scope Defining Documents is required, to reflect:

- the extension of the structured sub-elements of "postal address", with a dedicated NPC usage rule;
- the addition of the new optional sub-element "Purpose" under "Original Transaction Reference" for pacs.004/camt.029/camt.056:
- the addition of the element "Currency" under Debtor account and Creditor Account needs to be added as an optional element in pacs.008 and pacs.004.

TIPS message specifications for non-Euro currencies for pacs.008, camt.056, pacs.004 and camt.029 should be updated in order to include the abovementioned changes.

Regarding the NPC usage rule dedicated to Postal Address, the NPC Usage Rule requires a different behaviour as of 2025. The rule "Address line is not to be used after 2025. Only structured postal address elements must be used." will not be taken into consideration for this CR, as it will be a requirement for the future NPC 2025 CR.

An update of the TIPS functional documentation is required in the following areas, to keep track of the editorial changes and the amendment to the message specifications from this Change Request:

- TIPS UDFS;
- Message schema pacs.008, camt.056, pacs.004 and camt.029 for non-Euro community.

#### Summary of application development impact:

1 TIPS Router shall be updated in order process the new schema files and to remove the old ones.

2 TIPS Router shall be updated to add the validation of pacs.008 message shall implement the technical validation rules listed on second point of the three points listed in functional impact paragraph.

3 TIPS Testing tool shall be updated in order process the new schema files.

4 MEPT (Message Exchange Processing for TIPS, part of ESMIG) shall be configured in order to assign the new message types to the relevant MEPT property values.

5 MEPT documentation shall be updated to convey the information required for triggering the appropriate schema validation in TIPS, on the basis of the suffix in the MsgType property value, to participants. This shall be done in conjunction with CR TIPS-0052, by enhancing the Message Exchange Processing for TIPS (MEPT) protocol, which is used in the communication between TIPS and the Network Service Providers.

As of the date this CR is assessed, it has not yet been decided how the new rules will come into effect. There are two possibilities, either:

- The new schemas will enter into force at a precise point in time, putting in place a "recreate deployment" (it is subject to an all-or-nothing logic and ensures an immediate update of the whole system), to be realized stopping the TIPS platform before deployment and re-starting it after the new version is fully installed.
- The new schemas will enter into effect progressively, during a period of time in which they are optional and both old and new schemas coexist. At the end of the transition period, only the new schemas will be into force. (This is the TIPS usual "rolling deployment" strategy, the normal way any change is deployed in TIPS).



The costs stemming from the adoption of the specific deployment strategy will be assessed in a possible future CR, however the decision will have to be taken before the CR-0055 development starts, as the deployment strategy must be known at the time the change is designed.

Summary of infrastructure impact:

The impact on infrastructure is modest. The Site Reliability Teams will be involved in the day-by-day monitoring and will be assessing the change has no impact on existing services.
